Perched on the heights of Crest, this beautifully renovated, south-facing farmhouse is set on approximately 1 hectare of lush, private land, featuring a variety of plant species and offering unobstructed views.

The property offers around 170 sqm across two levels and includes four bedrooms, two bathrooms, and a spacious living room with breathtaking mountain views. It also boasts an open-plan kitchen, a terrace, a

garage, a cellar, and a carport for two vehicles, as well as a pool.

Ideally located, this home is close to local shops and schools, just 30 minutes from the TGV station and 20 minutes from a motorway entrance.

This tranquil yet accessible environment provides a stunning 180-degree panoramic view of the Tour de Crest, the 3 Becs, and the Roche Colombe mountains.

Improvement work is to be expected but the potential and its positioning remain exceptional.
