Property Description

A very unique opportunity to undertake a project to convert a large traditional Savoyard barn, in its original state, situated on the ski slopes and next to the ski lifts to the Nyon and to the Pleney mountains from the Fys area of Morzine.

Accessible by road, but with restricted access by digital badge only for property and business owners. A free ski bus runs into the centre, with a stop just 100m from the property.

Located in a zone that allows conversion of the building to create a habitable property. The upper barn has

over 260 metres squared of floor space and is over 6m high in the middle, allowing enough room to add an upper floor.

The ground floor of the property is laid out in the traditional way, with living space in three rooms occupying half the floor space and the other half having been used to house the livestock during winter.

Under one end of the building is a cellar that was used for storing meat and cheese, accessible by a trap in the floor.

Set in 1285 metres squared of land.
