Located in the classic residence, this 1-room flat + cabin has a carrez surface area of 63.30 sq.m and comprises an entrance hall with storage space, a living room with access to a balcony, a double bedroom with storage space and a mountain corner with a shower room. 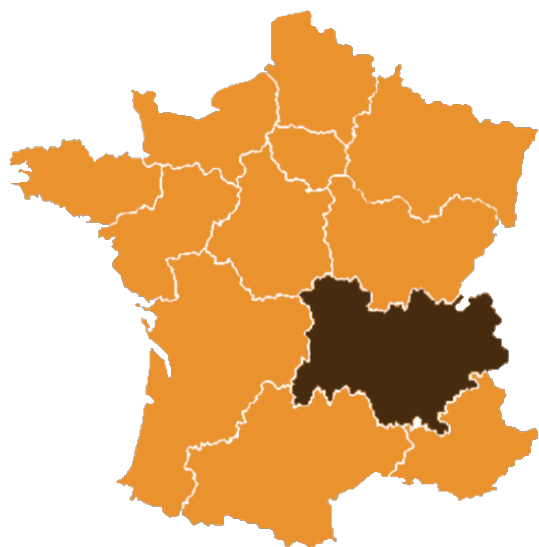
