Located at an altitude of 1035m, Praz sur Arly offers an ideal location: between Megève and Flumet, close to Mont Blanc, the Beaufortain and the Aravis.

Perched on the heights of the Grabilles district, along the chemin de Novex, the chalets of Tirecorde stir up all desires, located in the slope facing the chain of Aravis.

Perfectly integrated into their environment, they have been designed in such a way as to preserve the typical mountain architecture of the resort.

5 minutes from the village center and in the immediate vicinity of the slopes, they reveal stunning views and a quiet and private location.
