At the gates of Bordeaux, near Artigues, this contemporary house of 180 sqm, built in 2017, benefits from a resolutely modern architecture and is harmoniously located on a plot of land bordered by vines.

A private driveway leads to this residence with elegant lines, offering a generous reception area with several

parking spaces, a carport and a large garage of 40 sqm.

Upon entering, the ground floor reveals a vast living room bathed in light, decorated with an ethanol fireplace, as well as a cathedral-height dining room. The fully equipped fitted kitchen opens to the outside through large bay windows, creating a perfect continuity between the interior and the garden.
