The ground floor of the main house (approx. 200 m2) comprises an entrance hall leading to a living room with fireplace, a separate kitchen with access to the terrace, a bedroom with shower room and toilet, and a utility room. Upstairs, a landing leads to a large 36 m2 sleeping

area, two further bedrooms and a bathroom with toilet. The property also features a 10 x 5 metre swimming pool, two terraces and a pool house. it also has oil-fired heating and reversible air conditioning. The converted barn offers a vast 61 m2 living room with a sitting area featuring an insert fireplace, two large bedrooms, a full bathroom and a separate toilet. Upstairs is a 20 m2 mezzanine, two further bedrooms and a shower room. A 10 x 5 metre swimming pool, a lovely 60 m2 covered terrace, a laundry room and a pool house complete this barn, which was renovated in 2008. Underfloor heating is provided by a heat pump. The property is set in 9,700 m2 of carefully tended, fully enclosed grounds. Each house has its own independent gated access. This rare property in a quiet area is an ideal opportunity for both gites and family reunions.
