You enter the house directly into the 14m<sup>2</sup> kitchen which opens to the 25m<sup>2</sup> living space which enjoys lots of natural light and has a fireplace where you can add a wood burner.

There are three bedrooms (two of 11m<sup>2</sup> and 14m<sup>2</sup>) one of which has a view of the surrounding hills of the Gers countryside.

A larder and a moveable shelter are also at your disposition.

The windows are wooden framed and have an added pane of glass.

There is a 200 litre hot water storage tank. The property is served by an individual sewage system, septic tank. The attic is not insulated but there is a water barrier layer under the roof.

The land is fenced.

You will be 12 mins from Marciac, 16 mins from Mirande, 45 mins from Auch, 1h50 from Toulouse and 2h from the Atlantic Ocean.
