The living space is spread over 3 levels and set out as follows:

Ground floor: spacious entrance hall with woodburner, fitted kitchen, lounge/dining room with fireplace, WC. On this level an additional room with an independant entrance (bedroom/office or workshop) with access to a small courtyard. This room could be rearranged into a studio.

1st floor: 3 bedrooms each with ensuite shower rooms and a separate toilet.

2nd floor: a bedroom with ensuite shower room and dressing room, then a studio with living room and open kitchen, WC, ensuite bedroom with small south-facing balcony.

A 440m² garden not attached to the house is sold with the house.
