The ground floor of the house has a living room (20 m²), a kitchen (20 m²) and two bedrooms (19 m² & 20

m²).

Upstairs, there is 115 m² of attic space to convert to your liking.

Several farm buildings are available (+ 1100m²), surrounded by pastures, in addition to woods and forests (7 hectares) and 7 springs, 2 which are strategically installed.

Excellent facilities for rearing: cowshed (520 m²) with a loft (290 m²), 4 agricultural sheds for storing (1100 m²), a pigsty (50 m²) and a barn (60 m²).

The roof is recent. Heating, electricity, insulation and a septic tank will need to be updated.
