The hamlet is comprised of a superb home in the style of this Gascogne region, with 280m<sup>2</sup> of renovated living space, a salt-treated covered pool, fenced grounds with trees, a spring and a pond, outbuildings and three garages.

The hamlet also includes two homes to renovate with new roofs and three other buildings to renovate, requiring new roofs.

There is no obligation to carry out work on these various buildings.

A 40m<sup>2</sup> ex-wine press, old barn and a 160m<sup>2</sup> home have roofs which require attention and could be restored to suit your desires.

The hamlet is in a position central to the 7.5 hectares of woods and organic pastures which are partially fenced. The flat land is 100% exploitable.

A spring (water all year round) supplies a small pond and enhances the gardens filled with trees, a paradise for geese, ducks and sheep which live in harmony in this bucolic location.

There are almost 60 fruit trees which have been planted for a future abundant orchard.

You will be 10 mins from primary and secondary schools and all commerce and services, 20 mins from Auch, 1h from Toulouse, 1h40 from the mountains and 2h from the coast.

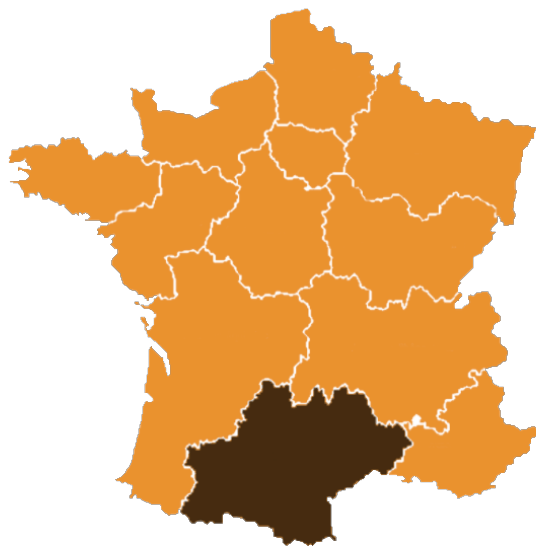
