Property Description

This former 19th century agricultural estate offers approximately 640sqm of living space on a plot of more than one hectare, a few minutes from Villefranche de Lauragais. The complex includes a large gîte, three guest rooms and a main house, organized around a first cloistered garden. The vast winter garden gives access to the cathedral living room of the house. This first level, as well as the adjoining kitchen, offers a

warm and ideal space for family moments. On the lower level, two master suites and the cinema lounge have direct access to the swimming pool and its completely unobstructed view of the surrounding woods and the Pyrenees. In the heart of the cloister, the three air-conditioned guest rooms each have their own bathroom. The independent gîte offers the possibility of sleeping 8 people, divided into a bedroom on the ground floor and a dormitory upstairs. The large fitted garage is equipped with all electrical requirements to create a catering space. The estate is powered by numerous photovoltaic panels, promising near autonomy in electricity. The car park also has an electric vehicle charging station. 
