Property Description

Located between Castelnau-Magnoac and Boulogne-sur-Gesse is this pleasant home to restore to modern tastes offering 145m² of living space (three bedrooms one of which ground floor) on 5900m² of land. There is a garage, a well, a pond and outbuildings.

The ground floor is comprised of a 23m² kitchen, 23m² living room and a 14m² larder. A step allows you to access a passageway leading to an 11m² bedroom, a washroom (shower and sink) and a toilet.

Upstairs, a 6m² landing serves two bedrooms, 22m² and 24m².

You will also have outbuildings including a 132m² livestock barn, a 16m² garage, a workshop and a henhouse.

Heating is provided by a fuel-powered system installed in 1996. There is an electric-powered hot water storage tank. Some windows are wooden framed and double glazed, installed in 1998. The roof of the house was relaid in 1987 and the garage roof in 2014. The loft was insulated in 2019. The property is served by an individual sewage system not up to current regulations.

You will be 10 mins from Castelnau-Magnoac for all commerce and services, 5 mins from Boulogne-sur-Gesse, 20 mins from Masseube, 50 mins from Tarbes, 1h30 from Toulouse, 2h30 from the Atlantic coast and the beach.
