


Renovated duplex crossing on the top floor

Property Description

A stone's throw from the famous Olive Market, this top-floor duplex of 128.44 m2 (122.02 m2 Carrez) with a continuous balcony of approximately 5 m2 facing south is located on the 5th and 6th floors of a Haussmannian building (elevator project in progress). This recently renovated property is characterized by its Haussmannian and contemporary variations. The apartment has a beautiful entrance with guest toilet. This leads to a vast living space with no vis-à-vis. On one side, a large kitchen fitted in black monolith fully equipped, accompanied by a pantry. On the other, a living room decorated with herringbone parquet flooring,

moldings and fireplace. The balcony extends the room and offers a view of the Sacré Coeur. Return to the entrance where a staircase that is both robust and graphic leads to the sleeping area located upstairs. It offers two bedrooms with a bathroom, a master suite with shower room, and a separate toilet. The volume, the layout, the brightness, the decoration with a contemporary spirit combining the colors of light wood, floor tiles punctuated in constellation with touches of black, the Haussmannian reminders make this duplex a family apartment with a certain cachet and subtle character. 


